IM c/o of pain - 8/10 states has been taking Ibuprofen 600 mg but not relieving pain well. Pain radiates to רו side head. IM c/o that his equilibrium is off and passed out last week. C/o facial sinus pressure pain and rep facial mass continues to enlarge.

Able to swallow but decreased sensation on the right side face and states biting tongue frequently when chewing and difficulty with swallowing food.

Denies fever, nausea, or vomiting.

Hx of a fib, valve surgery 2016, A fib, HTN, sinus pressure, and rt facial mass.

FHx of- father brain cancer passed away at age 72 and sister brain cancer at age 42 passed away. Hx of brother with epilepsy.

Labs wnl and facial x ray negative for osteomyelitis

HEENT- sclera nonicteric, conjunctiva pink, moist. Oral mucosa pink and moist and nasal mucosa eryther with clear small amt of drainage. Bilateral auditory canals clear no erythema or drainage, TMs visible and pearly color. No palpable thyroid abnormalities, no cervical lymphadenopathy palpated Rt side facial mass- visible, well demarcated, red, protruding, firm, slightly mobile, and tender- measuri cm wide and 5.5 cm long. No other skin lesions noted.

CV- RRR, S1, S2, no murmur, rub or gallop Resp- CTA b/l, no wheezes, rales, or rhonchi
